6.2 All fuel used shall be paid for by the Renter.

6.3 Minimum 7 days written notice must be given before returning the Vehicle.

6.4 In the event of accident the Renter should notify Owner within 24 hours of incident.

**7. EXCLUSIONS:**

7.1 The rented vehicle shall not be used to push, propel or tow another vehicle, trailer or any other thing without the written permission of the Owner.

7.2 The rented vehicle shall not be used for any race or in any competition.

7.3 The rented vehicle shall not be used for any illegal purpose.

7.4 The Renter shall not operate the vehicle in a negligent manner.

7.5 Vehicle should not go out of Victoria at anytime.

**8. INSURANCE:**

8.1 The Renter hereby agrees that he/she shall be held fully responsible for the first \$3000.00 deductible in case of accident. The Renter also agrees that personal belongings and other items left in the vehicle at any time are not covered.

8.2 The rented vehicle shall not be operated by any other person other than the Renter, without the written permission of the Owner. Otherwise Insurance will not be covered.
